

the level of Govt. High School & Govt. High School to the level of Govt. Sr. Secondary School in **Chamba** Distt. of the State. These schools are ordered to be made functional from next academic session i.e. with effect from 01.04.2014 subject to the condition that suitable accommodation i.e. (total 7 rooms for GHS & 14 rooms for GSSS available in the upgraded school as per norms, if additional accommodation is required, shall be provided by the local Public to run the upgraded classes.
