OFFICE ORDER

On the recommendation of the Departmental Promotion Committee, the following Junior Lecturer Assistant are hereby promoted as Senior Lecturer Assistant on regular basis in the pay scale of Rs.10300-34800 +3200GP and posted in Govt. Colleges as shown against their names subject to conditions that no complaint/ inquiry / vigilance case and disciplinary proceedings are pending against the individual concerned.

He/ She should report for duty to the concerned Principal with stipulated period. The Concerned Principal/ Headmaster will relieve the promoted Laboratory Attendant immediately. The salary of the promoted SLA's for the next month will be drawn from the College of his/ her posting. If the promoted SLA is not willing to avail the promotion he/she has no right to forgo the promotion in public interest, the Principal will take the option of non-availing the promotion from the concerned JLA. The copy of same will be pasted in his /her service book and the other copies be sent to this Directorate for taking further action. The promote SLA will join their new place of posting on or before 05<sup>th</sup> Feb. 2014 positively, failing which promotion orders as SLA shall deemed to be withdrawn automatically for one year or next DPC whichever is later. No specific orders with reference to withdrawal of promotion will be issued separately. No extension will be allowed in any case for joining.

The financial benefits will be admissible from the date of joining on the post of SLA. He/ She will be entitled TA/DA and joining time as admissible under the rule. He /She will have to exercise their option within one month from the date of promotion for fixation of pay under rule FR22 (i) a (i).

These posting are subject to the following conditions:-

1- In case the above promotee has been transferred to other institutions, the concerned Principal will ensure to send the promotion order to the institution where he has been transferred and report thereof be sent to this Directorate immediately.

2. In case the concerned promotee does not report for duty in the institution within stipulated period, the next incumbent in panel will be promoted. The Principal will ensure the submission of joining/ non-joining report to this Directorate within a week after the expiry of stipulated period.

3. The Principal of the concerned institution shall take an undertaking of the concerned official to the effect that if he is found unfit for promotion at a later stage due to any reason i.e. any change in the seniority / disciplinary proceedings etc, he will be reverted to the original post of Junior Lecturer Assistant and the excess amount paid to him will be recovered in lump-sum. The same be pasted in service book of concerned official duly countersigned by the Head of Institution.
