This is in reference to the LD. Advocate General to the Govt. of H.P w.r.t. his letter No. CWPIL No. 146/2017-Court on its own motion V/S State of H.P & ors on the subject cited above.

In pursuance to the directions passed by the Hon'ble High Court on 22.09.2017 and 16.10.2017 in CWPIL No.146/2017- Court on its own motion V/S State of H.P & ors. vide which the Hon'ble Court has directed to file the status report(s) well before 24.10.2017 by the Principals of all the institutions/ Deputy Commissioners/ Superintendents of Police as well as the Chief Secretary to the Govt. of H.P. The instant case was listed before the Hon'ble Court of H.P on 22.09.2017 and the Court suo moto take cognizance of an issue which is of vital public interest and importance.

In view of the above, all concerned authorities have to comply with the following instructions as per order passed by the Hon'ble Court on 16.10.2017 and send the compliance report to this Directorate through e-mail i.e. college_branch@rediffmail.com by today positively, so that status report could be filed in the Hon'ble Court on 24.10.2017.

1. As per the direction of the Apex Court students are entitled to concentrate on their studies without any unnecessary disturbance so as to ensure an atmosphere conducive for undertaking good education.
2. All the concerned authorities are directed to be very strict in maintaining high academic standards and maintaining academic discipline in their respective institutions.
3. No leniency ought to be shown in academic matters and the educational institution ought to be very strict in maintaining high academic standards and academic discipline.
4. It would be the responsibility of the students union organizing the function that persons who are not members of the student body or of the faculty do not attend such function. Disobedience in this regard by any student union may be viewed seriously.
5. The Hon'ble High Court has highlighted that presence of anti-social elements within the confines of the college will inevitably create a fear in mind of the students who may be left unable to adequately focus on the academics. Therefore, it may be ensured with the help of concerned police authority that no anti-social element enters the college during the conduct of such functions.
6. No activity other than the one connected with the affairs of the institutions shall be carried out in any of the campus, meant for imparting teaching to students in the institutions. Principals of all Govt. Colleges are hereby directed to ensure that activities conducted by the concerned student

unions are not carried out in a manner so as to be detrimental to education or interest of the students.

7. Ensure a peaceful and serene atmosphere in the colleges and take suitable steps for instilling discipline and penalize any person in accordance with law whom they find to be in violation of orders for maintaining congenial atmosphere in the colleges.
8. Hence court reiterated to all concerned for ensuring their conduct to be of such a nature which furthers the academic discipline of the institute and is not detrimental to it.
9. In order to organize the functions of student union peace fully in the colleges, all the heads of the institutions should liaison with the concerned local administration and police authorities. An advance intimation regarding organizing of the functions of student unions must be sent to concerned authorities of the local administration and police department so that anti social element could not disturb the discipline of the college.

In view of the above instructions of the Hon'ble High Court all the heads of the institutions are directed to adhere to these instructions in letter and spirit so as to maintain the academic atmosphere and discipline in the educational institutions. Photocopy of the order of the Hon'ble High Court in CWIPL No. 146/2017- Court on its own motion v/s state of H.P & ors is also enclosed herewith to more clarifications.

Mr. Shrawan Dogra, Advocate General with Mr. J. K. Verma, Dy.A.G. for respondents-State.

All the Deputy Commissioners of the State of Himachal Pradesh are impleaded as party respondents to this petition. Registry is directed to carry out necessary correction in the Memo of Parties.

2. Notice. Mr. J.K. Verma, learned Deputy Advocate General, appears and waives service of notice on behalf of the respondents.

3. On the basis of a letter addressed to the Chief Justice of this Court, comments of the District & Sessions Judge, Civil and Sessions Division, Kinnaur at Rampur Bushahr, were called for.

4. The state of helplessness expressed by the Principal is in the following terms:-

"1. That it has been requested ample numbers of times from the students to maintain the decorum of the institution by limiting the intensity of the functions. But it has been found that despite of repetitive request and guidance the real objective goes unachieved.

2. That the students of the college are found divided on dialectical groups for organizing their functions which is fore seen as the threat to the social makeup of the area.

3. The College administration is finding it difficult to control the mob that specifically is considered outsidous influence during the function.

4. That inspite of a good sound system installed and maintained to certain decibels, the students are hiring external auditory system that works beyond the prefixed sound limits. This causes a huge hindrance in studies and on going classes.

5. That the college tried to restrict the timings of the functions from 2 PM to 5 PM and strictly on holidays but due to external influences this aim again goes unmet.

6. That the faculty members are strictly deputed on duty to maintain the discipline during the function in the auditorium but, the faculty feels threatened by the unidentifiable mob gathered in the function.

7. That even the police department refuses to comply to maintain the law and order in the campus during ongoing functions due to the larger no. of functions being organized. (Copy attached).

Therefore it is pleaded that it may prove us a great help if suitable directions are given to us so as to improve the academic environment of the institution as well as that of students."

5. It is this, which led the Court *suo moto* take cognizance of an issue which is of vital public interest and importance.

6. In *Church of God (Full Gospel) vs. K.K.R Majestic Colony Welfare Association*, (2000) 7 SCC 282, the Hon'ble Apex Court held that students are entitled to concentrate on their studies without any unnecessary disturbance. Hence the question as to whether students' organizations have a duty to ensure an atmosphere conducive for undertaking good education has to be answered in the affirmative.

7. The Hon'ble Apex Court in *Director (Studies) v. Vaibhav Singh Chauhan*, (2009) 1 SCC 59 laid down that the authorities have to be very strict in maintaining high academic standards and maintaining academic discipline and academic rigour if the country was to progress. Hence court reiterated to all concerned for ensuring their conduct to be of such a nature which furthers the academic discipline of the institute and is not detrimental to it.

8. In the matter of maintaining discipline, the educational Institution must be given the right of exercising such power and right of the Principal to maintain peaceful atmosphere should be preserved and upheld.

9. No leniency ought to be shown in academic matters and the educational institutions ought to be very strict in maintaining high academic standards and academic discipline.

10. Therefore, it is directed that the concerned student unions conduct their activities in accordance with directions issued by the college administration in this regard. Moreover, it is also directed that it would be the responsibility of the student union organizing the function that persons who are not members of the

student body or of the faculty do not attend such function.

11. We direct that no function, save and except the one meant for the students and so permitted by the Principal, G.B. Memorial Government College, Rampur Bushehar, District Shimla, H.P., shall be held in the campus of the college.

12. We are shocked to note that the police refuses to cooperate with the college authorities in the maintenance of law and order. We highlight that presence of anti-social elements within the confines of the college will inevitably create a fear in mind of the students who may be left unable to adequately focus on the academics.

13. Therefore, we direct the Deputy Superintendent of Police, Rampur, Shimla to ensure that the college campus is adequately policed during the functions and no anti-social element enters the college during the conduct of such functions.

14. We further direct that no activity other than the one connected with the affairs of the institution shall be carried out in any of the campuses, meant for imparting teaching to students, be it a primary, secondary, higher or college levels. The Principal(s) of such institutions are directed to ensure that activities conducted by the

concerned student unions are not carried out in a manner so as to be detrimental to education or interest of the students.

15. We further direct the Principal(s) of the college(s) to take all steps as may be necessary to ensure a peaceful and serene atmosphere in the college(s). They may take suitable steps for instilling discipline and penalize any person, in accordance with law, whom they find to be in violation of orders for maintaining congenial atmosphere in the college(s).

16. It is the duty of the authorities concerned, more so that of the Principal(s), Sub Divisional Magistrate(s) and the Deputy Commissioner(s)/Superintendent(s) of Police to ensure maintenance of law and order.

17. We direct the Chief Secretary to the Government of Himachal Pradesh to forthwith issue directions to all the Deputy Commissioners, who shall personally ensure that the order are complied with in letter and spirit.

18. Let affidavit be filed on or before the next date of hearing.

In compliance to letter No. HHC/PIL/F-2002-/09-2017/26967 dated 20-09-2017, I accompanied by an official of the District Legal Services Authority, Kinnaur at Rampur Bushahr, visited G.B.Pant Memorial Govt. College, Rampur Bushahr and contacted Sh. Puran Chand Kashyap, the Principal of the aforementioned college. Since the complaint in question is an anonymous one, so I also contacted Miss Sonu Devi, the President, Miss Rubina, the Vice President, Miss Anjana, the Secretary, and Mr. Prateek, the General Secretary of College Student Central Association (CSCA), Rampur, appointed on merit basis for the present academic session by the authority of the aforementioned college, and also Mr. Anshul Jogi and Mr. Rahul, the President and Secretary, respectively, of SFI, and Dev Kumar, the President of NSUI, and Mukesh, Up Pradhan of ABVP, the leaders of aforementioned students organizations. The abovenamed representatives and leaders of the aforementioned Students Associations vide their separate statements made in their own handwriting and duly signed by them expressed their ignorance with respect to the complaint in question.

However, on the basis of the statements made by the above referred representatives of the Students Association and Union, it stands established that various functions are conducted in

thereof, many times altercations take place in the college complex resulting into law and order problem.

Above named Principal of the College also gave written reply with respect to the allegations made in the complaint and therein he virtually expressed his helplessness in denying permission to various students organizations to organize their functions inside the College Auditorium. It is clear from the reply given by the Principal as well as the members of the Associations selected on the basis of merit that academic environment is disturbed due to the frequent functions. 

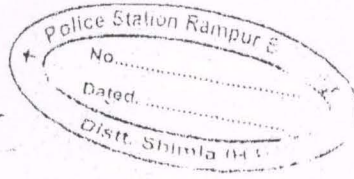

उपरोक्त विषय के सम्बन्ध में निवेदन है कि समय-समय पर राजकीय महाविद्यालय के छात्र संगठनों के द्वारा महाविद्यालय के सम्भार में सांस्कृतिक कार्यक्रमों का आयोजन किया जाता है, जिसमें उक्त छात्र संगठनों के सदस्य व छात्र शामिल होते हैं तथा कार्यक्रम के आयोजन के दौरान शांति व्यवस्था को बनाए रखने के लिए हर समय समय पुलिस सहायता की मांग की जाती है। इस विषय के सम्बन्ध में निवेदन है कि यह सांस्कृतिक कार्यक्रम उक्त छात्र संगठनों का निजी कार्यक्रम है तथा दौरान कार्यक्रम उक्त छात्र संगठनों का यह उत्तरदायित्व है कि यह शांति व्यवस्था बनाए रखे। क्योंकि राजकीय महाविद्यालय के सम्भार में किसी भी कार्यक्रम के आयोजन से पूर्व महोदय की अनुमति प्राप्त करना आवश्यक होता है, इसलिए भविष्य में कोई भी कार्यक्रम सम्भार में आयोजित होने से पूर्व उक्त छात्र संगठन से कार्यक्रम के दौरान शांति व्यवस्था बनाए रखने का लिखित आश्वासन प्राप्त होने पर ही उक्त छात्र संगठन को सम्भार में कार्यक्रम करने की अनुमति दी जाए व महाविद्यालय प्रशासन इस कार्यक्रम की मॉनीटरिंग हेतु अपना एक प्रतिनिधि नियुक्त करे जो पूरे कार्यक्रम पर पूर्ण नजर रखे तथा कार्यक्रम की अनुमति में ही महोदय द्वारा उक्त शांति व शांति किया जाए इसके बावजूद यदि कोई छात्र संगठन उक्त शांति का उल्लंघन करता है तो उसके आयोजकों के खिलाफ कड़ी अनुशासनात्मक कार्यवाही की जाए, यदि आवश्यक हो तो कानूनी कार्यवाही करने के लिए इस कार्यालय को सूचित करे। क्योंकि दिन प्रतिदिन थाना हजा में भी निजी कार्यक्रमों के लिए पुलिस सुरक्षा की मांग की जाती है जो अनुचित है क्योंकि थाना हजा पर पहले ही अन्य विषयों व सुरक्षा आदि के काफी उत्तरदायित्व है। क्योंकि महाविद्यालय के अन्दर किसी भी प्रकार का कार्यक्रम का आयोजन विभाग का आन्तरिक मामला है तथा इन मामलों में पुलिस का भार महाविद्यालय के अन्दर रखल देना उचित न है।
