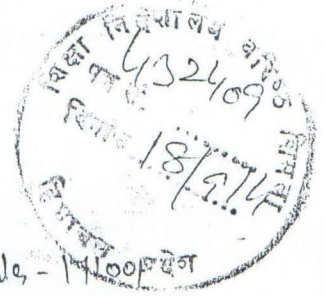

In continuation of Department's letter No.DE.9-22/94-III-2150-2300 dated 23.9.2013 on the above noted subject. It is stated that the applications for the Allotment of Govt. Residential Accommodation from General Pool for the next year i.e. 2015 are hereby invited.

It is ,therefore, requested to kindly bring to the notice of all the officers/officials of your department/office who are desirous for the Allotment of Govt. Residential Accommodation from General Pool to apply afresh for the year 2015 on prescribed Performa(DE-1 FORM) also available on departmental (Estates)website .Applications should reach before/on 15<sup>th</sup> December,2014 for next allotment year and as such applications shall be valid for one year. The applications received with ambiguous entries or leaving any column blank shall not be entertained and will be rejected summarily.

While forwarding the applications of the officers/officials, it may kindly be ensured that only those category or class of Govt. servants, for whom no departmental accommodation exists at Shimla, be forwarded on seniority basis as the Govt. servants of the category or class for whom departmental pool accommodation exists at the station of their posting are not eligible for allotment from the General Pool at that station. In addition, to it is generally noticed that applications of Officers/Officials of the Boards/Corporations who are on secondment basis and are not absorbed in concerned Govt.department may not be forwarded till such time they are not absorbed in Govt.Deptt.
