I am directed to refer to your letter No. EDN-H(Elc)(1)C-2/92-2008-10 dated 9th November, 2015 on the subject cited and to say that the matter was referred to the Election Department who has advised as under:-

"Examined Department is advised to consider the following observations:-

As per ECI's directions , one BLO for each polling station has to be appointed who is a local Government/Semi-Government Official, familiar with the local electors. In compliance with directions, total 7,382 BLOs have been appointed in this State. Out of 7,382 BLOs, 2,591 are teachers who are mostly from the C & V categories. In rural areas, some JBTs have also been deployed as BLOs due to non-availability of other Govt./Semi-Govt. employees. All the District Election Officers(DCs) are being directed from time to time to deploy minimum teaching staff on BLO's duty and where necessary, they should be drafted for BLO work during holidays and non-teaching hours and during vacations.



Further to minimize the working of BLOs amongst teaching staff as well as to avoid possibility of skipping the staff from the offices/Institutions on pretext of BLO's duty as noticed oftenly, all the DEOs/EROs have been directed to keep strict vigil and all the verbal communications be confirmed in writing so that proper communication with regard to actual performance of BLO's duty could be ascertained. The copies of aforesaid references issued vide this Department's letter No. 6-18/2013-ELN, dated 29th January, 2015 and 5th January, 2016 are also placed on file for kind perusal.

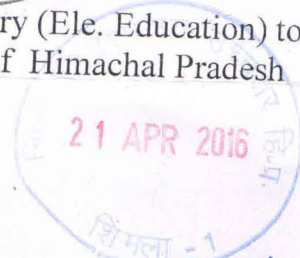
