Subject :- Regarding regularisation of Part Time Water
Carriers/Water Carriers-cum-Peon on daily wages
as Peon(Class-IV).

Sir,

I am directed to refer to the subject cited above and to say that it has been approved by the Government that Part Time Water Carriers and Water Carriers-cum-Peon on daily wages basis working in Higher/Elementary Education appointed under 1996 policy prior to 27/07/2001, who have rendered 17 years continuous service as PTWC or PTWC and Water Carrier-cum-Peon on daily wages basis(combined) til 31st March 2016 and 30th September, 2016 may be regularised as Peon(Class-IV) against the available vacancies of Peon (Class-IV) in Education Department, with immediate effect throughout the state.

It has further been approved that Part Time Water Carriers and Water Carriers-cum-Peon on daily wages basis working in Higher/Elementary Education appointed under 1996 policy prior to 27/07/2001 who shall complete the 17 years continuous service as PTWC or PTWC and Water Carrier-cum-Peon on daily wages basis(combined) til 31st March and 30th September in subsequent years may also be regularised, as and when they complete 17 years continuous service.

It has been also approved that the option may also be given to the Part Time Water Carriers and Water Carriers-cum-Peon on daily wages basis working in Higher/Elementary Education, who have become eligible or shall become eligible in subsequent years for regularisation for posting/adjustment in another district against vacant or surplus posts.

It is therefore, requested to take further necessary action in the matter accordingly
