## ORDER

WHEREAS vide this Directorate letter No EDN H(19)B(5)6/2010 dated 05.09.11 and dated 17.04.2012, 11 Ex-Serviceman Lecturers have been granted seniority after counting service rendered in Indian Army by the respective incumbents.

AND WHEREAS while preparing panel for promotion to the post of Principal (School) from feeder category of lecturers, various incumbents represented on the strength of directions passed earlier in CWP (T) No 5018/08 titiled as Harinder Pal Chauhan vs State of HP dated 08.10.2010 against assigning of this seniority to them which decision in its operation portion reads as under:

"It ha been pointed out that the aforesaid judgment of thi Court in <u>VK Beh I</u> vs <u>St te of HP nd others</u>, ha been challenged by filling an appeal in the Supreme Court. Therefore, it i directed that the benefit rendered in compliance with the aforesaid direction shall be ubject to the outcome of appeal, which i stated to be pending in the Hon'ble Supreme Court."

AND WHEREAS in the relied upon judgment of above case i.e. VK Behal vs State of HP, SLP titled RK Barwal & ors vs State of HP & ors was filed by the Ex-Serviceman candidates which was listed on 16.03.2009 when Hon'ble Apex Court has been pleased to pass following direction:

"In the meanwhile, statu qua, a of today, shall be maintained."

AND WHEREAS the above interim directions passed by Hon'ble Apex Court till now is also continuing and the directions passed in VK Behal case in CWP No 488/2001 dated 29.12.2008 on the issue of assigning seniority to Ex-Servicemen having been struck down which Hon'ble Apex Court in pending SLP has neither stayed nor over ruled. As such Ex- Servicemen candidate after 16.03.09 is not entitled for seniority till

VK Behal judgment is either struck down by Hon'ble Apex Court or the interim directions dated 16.03.09 are suitably modified. Rather for ex-servicemen candidates, after 16.03.2009 the department is to maintain status quo in view of Harinder Pal judgment.

NOW THEREFORE all the Ex-Servicemen lecturers as per the above direction passed by the Hon'ble High Court and Hon'ble Apex Court being not liable to be granted seniority which in view of order dated 05.09.11 and 17.4.2012 has been granted in their favour illegally. Instead of maintaining status quo qua, all of them as on 16.03.2009. Therefore, after considering above discussed detailed facts and circumstances prevailing in this case as per directions passed by Hon'ble High Court and Hon'ble Supreme Court, the office order/letter of this Directorate dated 05.09.2011 and 17.04.2012 are hereby withdrawn and all of you are hereby directed to explain your position within 15 days alongwith any contrary directions passed by Hon'ble Supreme Court if any failing which this order shall attain finality till further order/ till the direction of SLP titled as RK Barwal vs State of HP dated 16.03.2009 are modified or vacated.
