**Sub:- Regarding Restoration of advance increments of M. Phil / Ph. D after 01-10-2014 as per UGC norms.**

This is in reference to letter No. EDN-A(B) 7 7/2008 dated 6<sup>th</sup> Sept., 2017 received from the Principal Secretary (Hr. Education) to the Govt. of Himachal Pradesh, on the above cited subject.

In this regard, it is submitted that the Govt. has ~~been~~ decided that the advance increments granted prior to 1.10.2014 for Ph. D / M. Phil and other higher qualification as per para 7 of Annexure-II of this Department Notification No. EDN-A-B (7)2 / 2008 dated 15<sup>th</sup> October 2009 and amended from time to time shall continue to be allowed and no advance increments will be granted for Ph. D / M. Phil and other higher qualification after 1.10.2014. Due to that above increments has been stopped vide this Directorate letter No. even dated 16-06-2016, after 01-10-2014, as per direction of the Govt. those Assistant Professors / Associate Professors who have acquired M. Phil / Ph.D. Degree after 01-10-2014 and fresh entrant's on the post of Assistant Professor (College Cadre) will not be eligible for advance increments for M. Phil / Ph.D.

In view of the above, the matter regarding grant of advance increment to those Assistant Professors / Associate Professors who have acquired M. Phil / Ph.D. Degree after 01-10-2014 and fresh entrant's on the post of Assistant Professor (College Cadre) was taken up with the Govt. vide which Govt. has directed to re-examine the matter along with financial implication involved in the instant matter.

Therefore, you are requested to provide the individual wise details of the incumbents along with financial implication, who have not been given the said benefit after 01.10.2014, so that the same information could be submitted to the Govt. as desired at the earliest.
