



Copy of the letter No. EDN-A-B(6)8/2005-XI-L dated ~~16.01.2014~~ received from the Principal Secretary (Hr. Edu.) to the Govt. of Himachal Pradesh:-

Subject : Regarding GIA to the PTA Provided teachers engaged as per the GIA to PTA Rules 2006.

I am directed to refer to the subject cited above and to say that number of PTA provided teachers were/are providing their services before 31-12-2007 in different categories of the teachers in the Educational institutions in the state, but they are not fulfilling the requisite educational qualification required as per R&P Rules of the concerned category (ies). It was brought to the notice of the High Powered Committee a time of three years till 31-12-2010 was given to the lecturers (School cadre) for completing their requisite educational qualification i.e. B.Ed. as per R&P Rules and GIA was also released in their favour. The same demand was also came from various channels of the different categories as well as left out Lecturer( School Cadre) who didn't fulfill requisite qualification.

Keeping in view the requests, the High Powered Committee considered the matter in detail and recommended that all categories of PTA provided teachers be allowed to complete their requisite educational qualification till 16-08-2016 as per R&P Rules and it has also been recommended to release the GIA in their favour. Keeping in view the recommendation of the High Powered Committee, the matter has been considered by the Government and it has been decided to accept the recommendation of High Powered Committee to allow all the categories of PTA provided teachers i.e. Assistant Professors (Colleges), lecturers(School Cadre), Shashtries, TGTs, LTs, DMs, DPEs, PTIs etc. to complete their educational qualification till 16-08-2016 and till than GIA be released in their favour. Their candidature for taking over their services on contract basis will be considered only after they fulfill the requisite educational qualification as per the R&P Rules and no GIA will be given after 16-08-2016.


It is therefore, requested to take further necessary action in the matter under intimation to this department.
