Subject: Regarding allowing two special chances to improve the score in 10+2 examination.

Sir,

I am directed to refer to the subject cited above and to say that the National Council for Teacher Education (NCTE) in pursuance to the provisions of RTE Act has laid down the minimum academic/professional qualifications for appointment of various categories of teachers wherein minimum percentage of marks has also been prescribed. Presently, there are so many unemployed trained teachers who do not have minimum percentage of marks in 10+2 required as per the norms of the NCTE. As a result, such candidates have become ineligible. There might be similar cases in other Departments also as the R & P rules of almost all categories of employees have now been amended.

The above matter was under consideration of the Government for some time past. Now, it has been decided that two special chances be given to improve the score in favour of all the candidates who have passed 10+2 examination prior to issue of this letter.

You are, therefore, requested to take further necessary action accordingly under intimation to this Department.
