Instructions regarding implementation of Judgment passed by the Hon'ble High Court in LPA No.105 of 2010.

I am directed to invite a reference to letter No EDN-C-E(1)6/2013 dated 14.11.2013 from the Pr. Secretary (Education) on the subject cited above and to say that the aforesaid instructions are based on the advice of the Advocate General, H.P. a copy of which is being enclosed for ready reference (to be kept in record only). The advice given by the Advocate General and as also the instructions referred to above are quite clear and specific that only initial of the relevant post is to be given. The same does not envisage grant of any allowance including dearness allowance.

Despite the clear provisions of instructions it has come to the notice of Government that a number of field officers are presenting the bills in the Treasuries in which the dearness allowance /other allowances are being claimed. It is, therefore, requested that all such cases which are being /have been processed for determination of emoluments as per the instructions referred to above may be examined / reviewed strictly in the light of these instructions. In case any irregular payment has been made on account of the above the same may be recovered and deposited in the Govt. treasury forthwith and appropriate departmental action may be initiated against the officer concerned responsible for this lapse.

In order to ensure the correctness of the claims all the concerned officers may be asked to put a certificate of date of joining the contractual service and its cessation and drawn statement from the previous DDO as the bills being received do not contain this information which is necessary for verifying the claims.

The orders be brought to the notice of all concerned.
