It is to inform you that NSS State Level Mega Camp is scheduled to be organized w. e. f. 28/09/2017 to 02/10/2017 at GSSS Haroli, Distt. Una, H.P. The objective of the Mega Camp would be to make the youth aware about their responsibilities towards the Nation and inculcate moral values and develop work culture in them.

You are, therefore directed to depute active & dedicated Two NSS Volunteers (One Boy and One Girl) for this Camp. Height of the boys should be 165cm to 175 cm and height of the girls should be 155cm to 165cm. Participants will report to the Principal GSSS Haroli Distt. Una on 27/09/2017 (up to evening) and back return journey on 2nd October, 2017. Safe arrival and departure of volunteers will be the responsibility of the respective institution. In case of Girl volunteers, only female teacher may accompany the volunteers. Boarding and lodging arrangement will be provided by the organizers. Travelling expenditure of the Volunteers will be borne by the respective Institution out of the Regular Activities Fund. All the participants should bring their own beddings, utensils and daily routine toiletry items.

You are, also informed that the NSS Volunteers will be selected for National Pre-Republic Day Parade Camp during this Mega Camp. As such, volunteers may bring with them full NSS dress (NSS Track Suit, P.T. Shoes, NSS Cap etc.), musical instruments and traditional costumes /cultural dress etc. The volunteers should also bring with them the Photo Identity Card, NSS Volunteers-ship Certificate duly signed by the Principal, Medical/Physical Certificate and Indemnity Bond (specimen enclosed).
