Subject: - Regarding implementation of NVEQF under CSS "Vocationalization of Secondary Education" in H.P.

Memo,

It is to inform you that Vocational Education has been introduced in 100 GSSS of the State in five subjects from the session 2013-14 under NVEQF. Two trades/subjects have been introduced in each school and vocational trainers have been appointed to teach these subjects through different ten Vocational training providers (VTPs) in all schools. The process of establishment of workshops/laboratories is under way which may take some more time. However, arrangements for practical training for the students have been made with the coordination of some other department as per annexure-A.

Therefore, you are directed to contact the concerned department in your locality at the earliest so that the practical training of the student could be completed by 30.11.2013 positively. The provision of budget for the same has been made and will be released to you immediately. In the meantime, you may meet out the expenditure for this purpose from some other sources which can be reimbursed later.

Being a subject of technical nature some guest lecturers/experts are also required to teach these subjects in addition to the regular trainers. There is a provision of honorarium at the rate of Rs. 200/ per hour for the same and budget is being made available to you for this very shortly. Therefore, you are directed to arrange the guest lecturers/experts from concerned industry/department/organization and any concerned field at least twice in a week for each subject. As these courses were started too late during the current session and at least 200 study hours are to be completed for each vocational course at Level-1 and Level-2. Therefore, you are directed to make provision of extra time/extra period during zero period or after school hours as per your convenience so that required study hours as per the norms of the scheme could be completed during this session. A monthly report is to be submitted to the department regarding the activities related to NVEQF in your institution regularly.
