ANNEXURE-A

Terms and Conditions for appointment to the post of Clerk

- 1. The appointment of the candidate shall be subject to the final decision in CWP No. 783/2011-A and 4596/2011-E in the Hon'ble High Court of H.P. & SLP (Civil) No. CC-7273/2012 in the Hon'ble Supreme Court of India.
- 2. The post is temporary but likely to be continued. His/her appointment to the cadre is subject to review by the Government.
- 3. No TA/DA will be admissible for joining the service at his/her place of posting unless and otherwise admissible under rules.
- 4. The candidate will have to serve the department anywhere in H.P. and he may also to serve in difficult area notified, for a minimum period of 5 years.
- 5. The candidate concerned shall have to produce the certificate of his/her being citizen of India.
