*Submission of complete Bio-data for the post of Chairperson and Member in Himachal Pradesh Private Educational Institutions Regulatory Commission.*

Himachal Pradesh Private Educational Institutions Regulatory Commission was established by enacting the Himachal Pradesh Private Educational Institutions (Regulatory Commission) Act, 2010. As per Section 4 of the Act the composition of the Commission will be as follows:-

*The Commission shall consists of a Chairperson and maximum of Two members from amongst persons of eminence in public life or in the field of higher education or who have remained Secretary or above to the Government of Himachal Pradesh or held equivalent post in Government of India for a period of three years or more.*

*Provided that the Chairperson and the Members shall not be from the same field of specialization.*

*The Chairperson and Members of the Commission shall be appointed by the State Government, on the recommendations of a Search Committee, for period of three years or until he or she attains the age of 65 years, whichever is earlier such Chairperson or Member may be eligible for a second term subject to the upper age limit of 65 years.*

*Provided that after the expiry of the term of office, the Chairperson or the Member, as the case may be, shall be ineligible for further employment or any assignment in any of the Private*


