I am directed to refer to the subject noted above and to say that the establishment reports send by the Principal(s)/ Officiating Principal(s) (College Cadre) and Pracharya(s)/ Principal(s) (Sanskrit College Cadre) are required to be updated by including the following:-

 The services of 206 Assistant Professors in Mathematics, Economics, Music (Vocal), Commerce, Chemistry and Botany working on contract were regularized on 10<sup>th</sup> May, 2016. The information relating to those is required to be updated.

The fresh enrolment in coming semesters including PG Classes, if running
in any College is likely to be started very shortly. Accordingly, the updation
is urgently required to be done in Establishment reports being submitted by
each and every College(s) on monthly basis.

The information in respect of students enrolment (Major + Minor + Compulsory = Total enrolment) in each subject is required to be updated as per Annexure-B.

4. On 21st December, 2015 the Government had taken decision to reationalize

the posts in the subject of English throughout the State. After reationalization some posts have been shifted to some other College and remaining to surplus pool of DHE. In addition to this, a number of posts have been shifted in other subjects to other Colleges and surplus pool of Director of Higher Education as per requirement. Accordingly the updation is required to be done in Establishment reports (Column No. 3 & 4 of Annexure-A).

- 5. The services of 62 Assistant Professors working on PTA (GIA) were taken over on contract basis on 17<sup>th</sup> January, 2015. It has come to the notice that the Principal(s) of many College(s) has not mentioned the previous information in respect of these Assistant Professors, which is required to be updated immediately.
- A number of Associate Professor(s) (College Cadre) have been placed as Officiating Principal (College Cadre), the information is respect of these Associate Professors is also required to be updated.
- 7. In number of College(s), Assistant Professor are woking on local (PTA) which are not shown in the establishment reports received from the concerned College(s), which is required to be mentioned in Column No. 9 of Annexure-A.
- The information in respect of Assistant/ Associate Professor who have served in tribal area/ difficult/ hard area with period they have actually served, is required to be clearly mentioned in the column No. 13 of <u>Annexure-A.</u>
- '9. The information relating to ANO NCC working in the Colleges is also required to be mentioned in the column No. 16 of <u>Annexure-A</u>.

In addition to this, PMIS data in respect of Principals, Pracharyas, Assistant/ Associate Professors, Acharyas and other categories, working in Govt. College(s) and Govt. Sanskrit College(s) respectively and in respect of other categories is also required to be updated regularly on their transfer/ postings/ and evev in case of fresh appointment.
