Subject: Request for Family Data for extension of RSBY to the Contractual Employees.

Sir/Madam.

Rashtriya Swasthya Bima Yojna (RSBY) is being implemented in the State to provide the health insurance coverage to the tune of Rs. 30,000/- p.a. on family floater basis for different categories i.e. BPL, MGNREGA Workers, Street Vendors, Building & Other Construction Workers, Persons with more than 70% disability. In addition to Rs. 30,000/-, the scheme provides additional benefits of Rs. 1.75 lakh for treatment of major diseases under Critical Care. The State Government has decided to extend the benefit of RSBY to the Sanitation Workers, Rag Pickers. Auto Rickshaw & Taxi Drivers, Contractual Employees and Artisans/Weavers from the current financial year. Category i.e. Contractual Employees is not covered by Govt. of India, Ministry of Labour & Employment. Matter to include the contractual employees under RSBY and use on the spot registration and enrollment software was taken up with Govt. of India. The Govt. of India has not allowed to use on the spot registration and enrollment software due to difficulties faced regarding reconciliation of data. The data of all the contractual employees is required to be collected and validated from Govt. of India, Ministry of Labour & Employment before start of enrollment process. The current policy period is up to 31st August, 2014 and before that smart

cards are required to be issued to every eligible employee for having the benefit of complete twelve months policy.
