

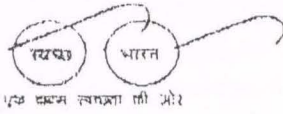

Dear Sir / Madam,

Kind reference is invited to the D.O. of even no. dated 3<sup>rd</sup> August, 2017 written by Additional Secretary, MHRD regarding training of untrained teachers. The registration at NIOS portal for all Govt. Govt. Aided and Pvt. Unaided teachers has already been started and the last date to register at NIOS portal ([dled.nios.ac.in](http://dled.nios.ac.in)) is 15<sup>th</sup> September, 2017.

2. We have been constantly updating you about the daily status of registration at NIOS portal. Till today only 25,101 teachers have registered at the portal and only 7764 have made payment of course fees. As per the figures available with this Ministry on the basis of 2015-16 UDISE data the total number of untrained teachers in all categories is 11 lakhs. Therefore, we need to undertake a thorough awareness campaign and make concerted efforts to speed up the registration.

3. You may also like to refer to Section 18 of RTE Act which provides for withdrawing recognition of any school which does not fulfil norms and standards as prescribed. The Private Unaided Schools may be addressed in view of the above mentioned Section of the RTE Act in order to ensure that all untrained teachers teaching in these schools register themselves at NIOS Portal.

4. Further, it is also informed that MHRD will not provide any financial assistance for undertaking the above training by Govt., Govt. Aided and Private Unaided Teachers.

5. It is requested that the matter may be given utmost priority to ensure that all untrained teachers are registered on the NIOS Portal by 15<sup>th</sup> September, 2017 and trained by 31<sup>st</sup> March, 2017.



Dear Sir/Madam,

As you all are aware about the training of untrained in-service teachers of Govt School, Govt Aided School & Private School at elementary level as per amendment in Section 23(2) of RTE Act, 2009. The online enrollment has already started on NIOS portal-dled.nios.ac.in from 16th Aug, 2017. The last date for enrollment is 15th Sept, 2017. As per the norms after 31st March, 2019 no untrained teacher will be allowed to teach at elementary level. You may also check status any time through <http://dled.nios.ac.in/dledstat1.asp>.

The state wise status of enrollment as on today (30 Aug, 2017) is attached for your reference. Till date only 69,675 teachers have registered at NIOS Portal. States where the numbers of such teachers are high i.e. Assam, Andhra Pradesh, Chandigarh, Punjab, U.P, M.P., Odisha, Rajasthan, Manipur, Chhattisgarh, Jharkhand, Karnataka, West Bengal, U.K. etc. may please take note of the situation and start a special drive for registration.

As per the information available with this Ministry, total no. of untrained teachers is 11 lakh, this requires monitoring at day to day basis. Therefore, it is requested to take an urgent action so that all untrained teachers are registered at NIOS portal by 15th Sep, 2017.
