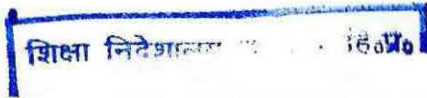

Sir/Madam,

In continuation to this office letter No. SIC 12(A)/2008 dated 31.1.2018 I am directed to inform you again that as per provisions of section 25 of the RTI Act, 2005 the Himachal Pradesh, State Information Commission is required to prepare a report on the implementation of the provisions of the Act, for the year in question and forward a copy to the State Government, for laying the same before the Himachal Pradesh State Legislative Assembly. For the preparation of the report, each Administrative Department is required to collect the desired information from the public authorities within its jurisdiction and provide the same to the Commission. This Annual Report has to contain the following information :

- i. The number of requests made to each public authority;
- ii. the number of decisions where applicants were not entitled to have access to the documents pursuant to the requests, the provisions of this Act under which these decisions were made and the number of times such provisions were invoked;
- iii. the number of appeals referred to the State Information Commission for review, the nature of appeals and the outcome of appeals;
- iv. particulars of any disciplinary action taken against any office/official in respect of administration of this Act;
- v. the amount of charges collected by each public authority

- vi. any facts which indicate any special effort etc. made by the public authority to administer and implement the Act.
- 2. You are, therefore, requested to collect the information for the year 2016-2017, from each public authority within the jurisdiction of your department as per proforma enclosed as (Annexure 'A') and send the same to this Commission. Since no fee is being charged from the persons who are below poverty line(BPL), the required information may be furnished separately for BPL category and non-BPL category in respect of each public authority.
- 3. Each public authority may also be requested to furnish the information in respect of 1st appeals filed during the year on the proforma enclosed.
- 4. You may mention special efforts if any, made by the public authorities to administer and implement the spirit and intention of the RTI Act, 2005. Since the Annual Report is required to be submitted to the State Government at the earliest to enable its laying in the Himachal Pradesh State Legislative Assembly, the desired information may be submitted immediately.
- 5. You are, requested to kindly give priority to the collection of the information and its submission. This communication may be ignored if the information has been furnished to this Commission
