Subject:- Re-scheduling of Information Practice(IP) exam of 10+1 class due to administrative reasons.

Memo,

It is brought to the notice of all concerned that the annual exam in the subject of Information Practice (IP), March 2014 of 10+1 class, which was earlier scheduled to be held on 26-03-2014, has been cancelled due to administrative reasons and has now been **re-scheduled on 02-04-2014, with same timing and venue of this exam.**

In view of above, all DDHEs in the State are hereby directed to collect the question papers for this subject from the office of the Secretary, H.P. Board of School Education, Dharamshala, Dist. Kangra **on 28-03-2014(forenoon)** and to ensure that same may be delivered to all the Heads of concerned institutions under their control well before the conduct of said examination. All Dy. Directors of Higher Education must inform all Heads of Institution in their respective Districts accordingly on top priority.

It will be sole responsibility of the all Dy. Directors of Higher Education to **collect the question papers from the office of the Secretary, H.P. Board of School Education, Dharamshala, Dist. Kangra and heads of the concerned institutions will be responsible to collect the question papers from the office of the Dy. Director of Higher Education** of their respective Districts.

Further, in case of inaccessible snow bound areas where question papers can not be delivered well in time due to the extreme climatic conditions, the concerned Dy. Director of Higher Education **will authorize the concerned Heads of Institution to prepare**

question paper for this subject, so that examination can be conducted as per the same schedule and the certificate to this effect will be submitted by the concerned Dy. Director of Higher Education to Secretary, H.P. Board of School Education, Dharamshala as well as to the undersigned that the question papers could not be delivered because of snowbound areas, despite best efforts.

All the Dy. Directors of Higher Education of concerned Districts are also directed to ensure that result of 10+1 class is declared **on 5th April, 2014, uniformly in all the schools.**

This may be given personal attention and top priority please.
