The some schools have informed to this Directorate that they are not in a position to do this work/ filling up online application of Atal innovation Mission properly and further requested to provide help for the said purpose.

Now the Govt. has informed the last date for applying for setting up of Tinkerin Laboratories under Atal Innovation Mission (AIM) is 15.07.2017 on NITI Aayog website i.e.<http://niti.gov.in/content/atal-tinkering-laboratories>(Copy enclosed).

In view of the last date declared by the Govt. i.e. 15.07.5017 to apply for the scheme, you are directed to take personal interest in the matter and assist all the schools concerned to do the needful to avail benefit of the scheme and make it sure that the schools concerned shall fill up the on line form on NITI Aayog website i.e.<http://niti.gov.in/content/atal-tinkering-laboratories> to enroll themselves with the scheme before the last date.

It is further requested to identify the eligible schools to establish ATL as per eligibility criteria for schools and providing necessary assistance through I.P/ IT Teachers /Science PGT/ lecturers to the eligible schools at their schools level / Deputy Director level for filling up online application of Atal innovation Mission and further submit online application on or before 15.07.2017 positively. It is also requested to supply the list of schools of your District who have submit the online application for ATL immediately to this Directorate .

You are further informed that if any assistance/clarifications is required regarding the on line process to fill up the form, the concerned schools may be directed to report in the concerned Deputy Director Offices/RMSA Shimla or IT Cell of this Directorate on or before 15.07.2017 alongwith complete records/ documents as required in the eligible criteria to establish ATL .If any negligency found in the said matter the defaulter officers/officials will be held responsible and action be taken against him under rules.

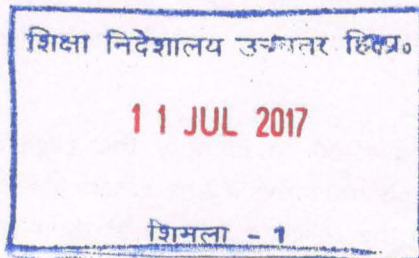


Setting up of Tinkering Laboratories Under Atal Innovation


