## Subject:- Regarding Service Delivery through Aadhaar.

As you are aware Himachal Pradesh is one of the leading States in the country in terms of Aadhaar generation (93%) and DBT implementation. Benefits amounting to Rs.30 Crore have been disbursed to twenty three thousand beneficiaries under various Government Schemes. However, there may be leftover residents who still have not received their Aadhaar letters or have not yet enrolled.

In view of the above, the following actions need to be taken to cover & extend the benefit to all citizens:-

Citizens whose Aadhaar numbers are generated but Aadhaar letters are not yet delivered may be educated about the e-Aadhaar facility which is available on UIDAI portal (eaadhaar.uidai.gov.in). This facility of checking and downloading e-Aadhaar is also available on Lok Mitra Kendras (LMKs)/ Common Service Centres (CSCs).

Enrolment Number, in case of those citizens who have enrolled but have not received the Aadhaar number may be collected and forwarded to IT Department.

Citizens who are yet to be enrolled may be requested to visit nearest Permanent Aadhaar Enrolment Centre available at District or Block Headquarter.

Further, all Departments must ensure that no citizens is deprived of any service for want of Aadhaar number in case he/she is otherwise eligible/ entitled. In case the citizen does not have Aadhaar then suitable exception handling mechanism may be evolved wherein other available POI/POAs may be accepted. Please ensure that the instructions already issued in this regard are modified accordingly.
