It is informed that a meeting of the core committee constituted on 23/07/2015 was held in the Chambers of Member Secretary, H.P. State Legal Services Authority, Shimla on 24/07/2015 at 12:00 P.M. The following decisions were taken:

- This year, the fresh plantation will be done by students of 6th standard as also college students of all Government colleges.
- The students of 7th to 12th standard who were involved in plantation last year shall maintain the old sites. The Forest Department will access the survival rate of the plantation carried out last year by the school children and accordingly carry out replantation in such sites where the success rate is less than 90%.
- The new sites for the student of 6th standard shall be near the schools and within 2 Kilometer distance from schools. While carrying out plantation in the school compounds, the same will be done keeping in view the area required for expansion of school building/ground.
- It was decided that one fresh laddu, one banana and two glucose biscuits will be provided by the Forest Department to all the students taking part in the Afforestation drive.
- It was also decided that Forest Department will access as to how many plants are to be planted in a particular site by the College students and such detail will be sent to this Department and only those number of students of Govt. Colleges will be taken to such sites.

- It was also decided that the Forest Department will provide transport to the students taking part in Afforestation drive wherever required.
- It was also decided that entire afforestation drive shall be completed well before 21/08/2015.
