Dear Shri Rizvi,

Kindly refer to my DO letter No. Pen-1.Minutes of Meeting/2013-14/ 512-532 dated 17 May 2013, through which I had communicated the shortcomings concerning GPF and Pension cases submitted by DDOs to our office. The shortcomings conveyed vide my letter referred to above still persist. Therefore I again request you to impress upon the DDOs of your department who are responsible for submission of GPF final payment cases and Pension cases to my office, to send the cases of GPF final payment three months before the date of retirement of the subscriber and the Pension cases six months before the retirement of the government servant.

Further, due to unfortunate incident of fire in our office, some cases of GPF final payment, Pension and Pension Revision had got burnt. Till date we have cleared maximum cases and our office is following up the remaining cases with concerned offices of the state government. However, there is chance that due to destruction of data, some cases might have been left out of our information system. I would be highly grateful if you could instruct the officers of your department to bring to notice of our office, those cases of GPF final payment, Pension and Pension Revision etc. which have not been received back from our office even after a lapse of two months.

I had requested vide my DO letter No. Funds-1/Misc./ 13-14/2798 dated 5 February 2014 to direct the DDOs of your department to furnish the nominations as records in our office had been destroyed in fire. Till now we have received nominations from very few offices. I shall be grateful if you could direct them to submit the nominations urgently.

Recently the Government of Himachal Pradesh vide notification No. Fin(c) -A(3) /2003 dated 28 May 2014 have allowed the option to the officials/officers of the state government to avail one year's extension in service. Meanwhile our office had finalised cases of Pension and GPF final payment and had returned the same to the DDOs/District Treasury Officers. All the authorities of pensionary benefits and GPF final payments are required to be returned to this office along with non-payment certificate(s) by the DDOs/ DTO in those cases where extension for one year has been granted to the official/officer concerned. Therefore the DDOs of your department may be directed accordingly.

I shall be looking forward to your kind cooperation.
