
Sir,

In continuation to this Directorate letter of even no. dated 04.01.2016 and Sensitisation Workshop held on 19.01.2016 with all the Universities (Govt. & Private) in the Conference Hall of the Directorate of Higher Education and thereafter the reminder of even no. dated 02.02.2016 regarding the uploading of the DCF form on AISHE Portal for the All India Survey on Higher Education 2014-15 and 2015-16 before the Target date 28.02.2016. as per the direction of the Hon'ble Union Minister of Human Resource Development, Smt. Smriti Zubin Irani on the launching ceremony of AISHE 2015-16 dated 21.12.2015 at Vigyan Bhavan, New Delhi.

In this context, video-conferencing were organized on dated 15.01.2016 and 16.02.2016 by Ministry of Human Resource Development with the Principal Secretaries of Higher Education in the States/UTs'. In the video-conferencing, it has been observed that the progress of data uploading in Himachal Pradesh as compared to other States is not encouraging which is a matter of great concern.

Subsequently, a meeting was called by Additional Chief Secretary Education on 17.02.2016 in his Chamber in the afternoon (2P.M.-3P.M.) where he has strictly directed that uploading of the data on AISHE Portal for the Year 2014-15 and 2015-16 be completed at all cost before the Target date 28.02.2016. positively otherwise RUSA grant of the State will be adversely affected for which the non-responding institutions will be held responsible. Therefore, you are requested that AISHE data for the above-said years may kindly be uploaded on the AISHE Portal before the Target date.


