Regarding apply/ verification under Pre Matric and Post-Matric

Scholarship Schemes of ST Students during the year 2016-17.

Sir,

Kindly refer to letter No.17011/02/2015-Education- dated- 22/12/2016 received from the Government of India, Ministry of Tribal Affairs, Shastri Bhavan, New

Delhi on the above cited subject.

In this context, it is to inform that having a number of queries on the NSP 2.0 Portal, some of which are summarized as below:-

1. If the application is rejected by the institute by mistake, there is no way that application can be received.

2. There is no provision for applicants to apply for renewal cases in case they have missed

- 3. The verification Statistics are not divided according to appropriate levels, hence States are having difficulty in verification process.
- 4. The application is not visible on the students domicile State portal even after it is verified by the institute where the student is Studying.
- 5. Even within a state, if a student from one district studying in an institute located in another district, authorities of the former district are unable to verify the details.
- 6. Some eligible Students could not apply online on NSP due to facing difficulties.

As a result of the above queries on the NSP Portal, verification is getting delayed in some cases, States should therefore design their own flow chart insofar as verification of application and related documents is concerned and ensure the payment is not stopped for this reason.

In view of the above the data of Pre Matric and Post Matric Scholarship Schemes for ST Students have already been transferred from NSP2.0 to HP e-Pass Portal of the year 2016-17 for new Student registration/verification.

All Head of the institutions/ Scholarship In-charge/Students are directed to upload the necessary/required documents under the Post Matric Scholarship Scheme whose parent's income is above 50,000/ (Fifty Thousand only) Per Annum.

The Department is going to extend the dates for new Student Registration under Pre/Post Matric Schemes in the Second week of March through e-pass Portal for the left out Students and verification of all ST Students who were applied through NSP2.0. If any, Head of the Institutions/Scholarship In-Charge/Student fails to submit their online application/verification/verified list (hard copy) within a stipulated time period, the authorities of the concerned institution would be responsible for any lapse.
