

Regarding upload the date of Assistant/ Associate Professor (College Cadre) of Government Degree Colleges and newly opened Colleges of HP on PMIS.

This is with reference to Government Letter No.EDN-A-(B)6-9/2013-Misc dated 03.06.2014 on the subject cited above.

In this connection, it has come to the notice of the Government that service record of most of the Assistant/ Associate Professors and other staff has not been uploaded by institutions regularly on PMIS. Due to non-availability of service record of above mentioned categories on PMIS, it has become difficult to the Government to make transfer orders on PMIS. You are therefore directed to ensure the updating of the data relating to PMIS (including newly opened 14 colleges) within a week positively, so that the transfer orders could be issued only through PMIS.

This slackness has been viewed very seriously by the Government, hence you are hereby directed to explain your position for not updating the PMIS data regularly. As directed by the Government, category wise completion report should reach this office on or before 20.6.2014 through e-mail- sunilcollegebranch@gmail.com .
