



The copy of said notification has already been endorsed to you by the Government for taking immediate necessary action and further sent to the Principal/ H.M concerned of your respective Districts . It is directed to ensure that these institutions are made functional only after completing all codal formalities.**

It is also further directed to forward the compliance report of functioning of the upgraded institutions with building status in consolidated manner to this Directorate with in a week positively by mentioning the date of starting of classes in these institutions alongwith following information i.e. (1) Name of Institution and Panchayat (2) Name of Block, Tehsil & constituency (3) Name of DDO, Pin & Treasury Code & complex (4) Name of Co-ordination Cluster (5) Whether institution comes under Sub Cadre area/ Difficult Area/ Tribal area mentioned separately. **The constituency-wise list of all GHSs & GSSSs running in your District may also be provided to this Directorate immediately, so that Govt. may apprised accordingly.**
