

REG: - REQUEST FOR GOVT. DEPOSIT IN OUR BANK

We wish to inform you about Himachal Gramin Bank, a scheduled commercial bank sponsored by Punjab National Bank came in existence on 23.12.1976 and is authorized to affect banking transactions as permitted under section 5(b) of Banking Regulation Act, 1949.

Government of India, Ministry Of Finance, vide its Extraordinary Gazette Notification No 347 dated 15th February 2013 amalgamated two RRBs in the state of Himachal Pradesh, i.e. Parvatiya Gramin Bank sponsored by State Bank Of India and Himachal Gramin Bank, sponsored by Punjab National Bank, into new single Regional Rural Bank known as Himachal Pradesh Gramin Bank, with its Head Office at Mandi, under the sponsorship of Punjab National bank.

The Government of India, the Himachal Pradesh State Government and the Punjab National bank (Sponsored bank), which has sponsored our bank contribute to the share capital of our bank in the proportion of 50%, 15% and 35%, respectively.

Background:

The operational area of Himachal Pradesh Gramin Bank is spread over all the 12 districts of the state with its network of 244 branches.

The prime objective of establishment of the Bank is to provide basic banking facilities to the remote rural sectors and to provide the facility to rural masses to deposit their savings in a secured manner. Another important responsibility entrusted to the Bank is to provide productive credit.
