Follow-up action on Budget Assurance of Hon'ble Chief Minister in Budget Speech for the year 2016-17, regarding designating two senior secondary schools as model school in each Assembly constituency to be started under Chief Minister Adarsh Vidyalaya Yojna .

It is in reference to the Budget Speech of Hon'ble Chief Minister for the year 2016-17 at Sr.No. 57 Para No.103,point-2 the Hon'ble C.M. has given assurance that Chief Minister Adarsh Vidyalaya Yojna to be started by designating two senior secondary schools as Model school in each assembly Constituency will have state of Art infrastructural and teaching facilities. (copy of budget Speech enclosed).

In this regard, you are therefore, directed to examine the matter and Inspect/ select any Two Govt. Senior Secondary Schools from existing GSSSs in the each Assembly constituency in your respective District with the consent of concerned M.L.A . for designating as Adarsh Model School. These Govt. Sr. secondary schools must be running with all streams i.e. Arts, Science, Commerce, Vocational subjects, I.CT. Lab., and having good student strength and adequate space to be developed as Model Schools ,(form class 9th ,10th,11th & 12th , 300 students and class 6th to 12th up to 400 students). The objective of Model School is to provide good quality modern education, including a strong component of culture, awareness of the environment, adventure activities and physical education and to serve in each District, as focal point for improvement in quality of school education through sharing of experiences and facilities.

The Broad Parameter for Development of Model Schools in H.P. issued by the Government is as under:-

- (i) Education provided in a Model school should be holistic and integral touching upon physical, emotional aesthetic development in addition to academics.
- (ii) Existing Govt. Senior Secondary school having good student strength and adequate space for development shall be developed as model Schools 9th ,10th,11th & 12th 300 students and 6th to 12th up to 400 students.
- (iii) Necessary infrastructure will be provided in such schools not only for satisfying teaching needs, but also for sports and co-curricular activities. There will be sufficient scope for sports , recreation and outdoor activities. Facilities like play ground, gardens, auditorium etc. will be provided in Model schools. A good library with books and magazines for students and teachers will be provided.
- (iv) These schools will have adequate ICT infrastructure internet connectivity and full time computer teachers. special emphasis may be given on teaching of Science, Math and English. If required, bridge-course may be introduced for weak students . All 3 streams namely , Arts, Commerce and Science should runs in such schools.

- (v) The Teacher Pupil Ratio should not exceed 1:25 and the classroom will be spacious enough to accommodate at least 30 students. However, classroom-students ratio will not exceed 1:40.
 - (vi) The schools will have to follow the national Curriculum framework 2005 and its subsequent versions as adopted by the Govt. of India time to time. At the same times, the curriculum should cast the local culture and environment and learning should be activity based.
 - (vii) The school curricula should include the material/items that inculcate leadership qualities, team spirit, participation abilities, development of soft skills and ability to deal with real life situation.
 - (viii) Regular health check-up will be introduced in these schools.
 - (ix) Vocational Education will be introduced in these schools.
 - (x) These schools will have facilities to cater to disabled children and should have special teachers.
 - (xi) The schools may provide for NCC training for students to inculcate the value of nationhood among them, as also to make them appreciate a disciplined way of life.
 - (xii) Model schools will have appropriate pace setting activates so that schools in the neighborhood, can benefit.
 - (xiii) Residential facilities can also be considered on need based basis.
 - (xiv) English Medium can also be considered for interested students. The DHE will be copetent to consider such cases and accord approvals.
 - (xv) Schools Management Committee may also be given freedom to take decisions on school uniforms and related matters.
 - (xvi) The Government will take a decision for designating a schools as Model school and on notification the DHE will prepare a perspective Plan to upgrade the school as Model School.
 - (xvii) The Government may also frame norms for transfer and posting of Principals/ Lectures/Teachers/staff to be posted in these institutions so that best talent is posted there.

It is also informed to you that the Govt. has framed above broad parameter for development of Model Schools in H.P. vide letter No.EDN-(B)-A(1)2013 dated 15.06.2015. As per Govt. direction the committee has already been constituted by the Department for selection of Adarsh Model schools in H.P. and issue of quality of teaching and students learning outcomes in the schools, vide this Dte. Office Order of even number dated 06.07.2015, the same has been endorsed to all the Dy. Directors of Hr. Education and all concerned offices/ officials to prepare the plan of action for improving the quality education. But the action taken report of this matter is still awaited from all concerned Offices.

You are therefore, once again requested to look into the matter personally and supply the following information for selection of designating as Adarsh Model School of any Two GSSSs in each constituency of your district which is urgently required on the format given below:-

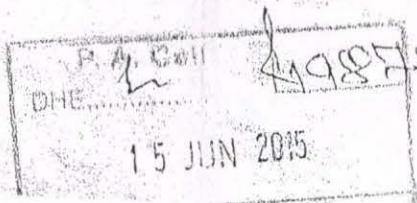
"F.D observes that AD is already running Model Schools backward blocks especially identified for the purpose. From the present scheme of things prescribed by AD, it is not clear how far this present scheme is different from the already running Model School Scheme. Secondly, it goes against the very logic of equal opportunity for all that we encourage some elite Model Schools while leaving the other schools behind. As such, AD should work for improving the quality of education in all the government schools. The quality of education will depend on accountability of teachers to deliver results, changing the class room environment from mere teaching to learning and, strengthening & employing the SMC (i.e. parents, whose children are studying in the school), as they have stakes in better working of the schools."

You are, therefore, requested to go by the FD's advice and prepare plan of action accordingly.

Further you are, directed to appoint an Officer of the rank of Joint/ Addl. Director to monitor the issue of quality of teaching and students learning outcomes in the schools.

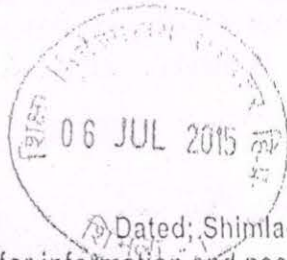
