OFFICE MEMORANDUM

Subject:- Casual leave benefits to the PTA provided teachers working under GIA Rules 2006.

Keeping in view the large number of requests of PTA provided teachers, the High Powered Committee constituted under the Chairmanship of the Chief Secretary to the Government of Himachal Pradesh, considered the matter and recommended that all the PTA provided teachers working under Grant in Aid Rules 2006 be allowed eight days casual leave in a calendar year.

2. Therefore, after careful consideration of the matter, it has been decided to allow upto 8 days casual leave to the PTA provided teachers working under Grant in Aid Rules 2006 in a calendar year with immediate effect. The casual leave not availed till 31st December shall not be carry forward to the successive year at any cost.
