Subject: Regarding implementation of New Centrally Sponsored Scheme of Post-Matric Scholarship for the Students with Disabilities effective from 1st April, 2014.

Memo,

With the introduction of New Central Sector Scholarship Scheme for Post Matric students with Disabilities, the applications are invited on National Scholarship Portal i.e. <http://www.scholarships.gov.in> for the year 2015-16. In this regard, All Heads of Institutions / In-charges are informed to submit the online application forms before 31st August, 2015 for the year 2015-16, through the Central Govt. Portal named National Scholarships Portal (NSP) the URL / website i.e. www.scholarships.gov.in, in r/o all eligible students of their institutions, under the Centrally sponsored for Post Matric students with Disabilities.

Under this scheme, all students having more than 40% disability, certified by the Competent medical authority of the state Govt. & whose parental Income from all sources does not exceed Rs. 2, 50,000/- per annum are eligible for full scholarship (i.e. Maintenance Allowance+ Compulsory fee) for all courses, provided they are pursuing their studies in Govt./Govt. Aided/Recognized Private Institutions.
