Subject: Implementation of Supreme Court orders passed in Civil Appeal No.4064 of 2004 titled S.D. Bandi V/S Divisional Traffic Officer, KSRTC & Ors dated 5.7.13-vacation of Government accommodation thereof.

Sir,

Kindly refer to this department letter No. S.Gr./2005-294-345 dated 21.12.15 addressed to All the Heads of Departments on the subject cited above, vide which it was requested that in view of the Hon'ble. Supreme Court orders, all Heads of Department were to intimate the latest status in respect of the date of retirement, transfer from and posting at Shimla, of their employees who have been allotted accommodation from General Pool; to facilitate timely vacation of the Government accommodation on retirement and transfer of such employees. It is regretted that despite repeated requests, no H.O.D has well in time informed till date about the date of retirement and transfer etc., of their employees occupying Government accommodation at Shimla. This casual approach has been causing inordinate delay in vacation of Government accommodation resulting in avoidable litigation to be initiated by Government under H.P.Public Premises Act against employees to get accommodation vacated.

You are, therefore, again, requested that the date of retirement /transfer may kindly be supplied well in time(i.e. within a week's time of such eventuality) to this office, so that the Government accommodation be got vacated in time. It is further requested to ensure at least three months before their superannuation, an undertaking to this effect be obtained from the allottees that they will vacate the Government accommodation allotted to them within a stipulated period(i.e. four months) as specified under Rule 10(2) of H.P.Allotment of Government residences Rules 1994.
