Subject:- The Constitution (Eighty-Fifth Amendment)Act, 2001-Seniority of SC/ST Government servants on promotion by virtue of rule of reservation /roster—Supreme Court Orders thereto.

Sir,

I am directed to invite your attention to this Department's letter of even number dated the 24th October 2002 on the subject noted above, vide which it was decided to fill up the promotional posts on adhoc basis by following the same procedure as is followed for making regular promotions. As a result of adhoc promotions, the promotee officers/officials are being denied the right to exercise their option under FR-22. This matter has been reconsidered by the Govt.and it has now been decided that the earlier instructions of dated the 24th October 2002 shall be deemed to have been amended retrospectively to the extent that the word" adhoc" contained in these instructions may be substituted by the word" regular" for filling up the promotional posts on regular basis where the regular procedure has been followed for making adhoc promotions in the past, so as to enable the earlier adhoc promotee officers/officials to exercise their option under FR22 for the fixation of their pay subject to the following rider:-

"This /these promotion(s) will however be subject to the final outcome on the Writ Petition (Civil)No.61/2002 titled M.Nagaraj & Ors.Vs Union of India &Ors and Writ Petition (Civil) No. 295/2002-titled Devi Ram Tanwar & Ors Vs Union of India & Ors. in the Hon'ble Supreme Court of India."

2. In the wake of above narration, the earlier promotion orders made on adhoc basis may be modified accordingly and in future, the promotional posts be filled in on regular basis with the same rider.

3. These instructions may kindly be brought to the notice of all concerned for compliance.
