Sir,

As you might be aware that Cyber Treasury for online collection of receipt has been launched by the State Government. At present customers having net banking account can make payment through online mode. Provision has also been made in the application software for generation of challans, to be paid in the attached bank by depositing cash. Generation of challan through system requires no manual entries besides removing classification errors while filling up the challan. Challans generated through this system carry HIMGRN number and can be directly deposited in bank without signatures of DDO or treasury.

It is, therefore, requested that all DDOs under your control may be directed to avail this facility and also impress upon the payees to generate the challan through this system.
