

Sir,

I am directed to refer to the subject cited above and to say that the Central Armed Police Forces (BSF, CRPF, CISF, ITBP, SSB, NSG and Assam Rifle) are engaged in guarding the borders and for internal security operations in the States. The personnel of CAPF are executing their duties in the most challenging and hostile areas of different States continuously and consistently with great operational success. They are also deployed in the most challenging situations like disaster management, communal riots, Security vital installations, etc.

During the course of their duties many of CAPF Personnel have laid down their lives and made the supreme sacrifice for the country keeping their facilities in very bad condition. Therefore, the Ministry of Home Affairs, GOI frequently requests the State Government to consider extending suitable benefits to them on the lines of benefits extended to Ex-Servicemen. Some States have already extended the benefits on the analogy of Ex-Servicemen to Ex-CAPF.
