As you are aware the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation of Rights) Act, 1995 mandates *inter alia* provision of barrier free access for the Persons with Disabilities both in transport, and built environment/roads. The following Sections may be specifically quoted:

Section-44: To support activities relating to non-discrimination in transports such as adaptability of rail compartments, buses, vessels, waiting rooms etc.(To the extent transport services are provided by State Governments or their PSUs);

Section-45: To support for barrier free access and non-discrimination on roads such as installation of auditory signal, devising appropriate symbols of disability, warning signals at appropriate places etc.

Section-46: To provide barrier free environment for the persons with disabilities which include access to build environment in offices and public buildings, health centres/hospitals, rehabilitation centres etc. It includes provisions for ramps, rails, lifts, adaptation of toilets for wheelchair users, brail symbols and auditory signals, tactile indications etc.

2. Further, as a signatory to the UN Convention on Rights of Persons with Disability also, our country is under obligation to provide barrier free access in buildings, work places, roads, transports and outdoor facilities etc.

3. The Govt. of India from time to time has been reiterating the need for meticulous implementation of the provisions/obligations cited above and have issued directions to State Govts./UTs to this effect. Letter No. 16-66/2013-DD.111 dated 13<sup>th</sup> November, 2013 addressed to the Chief Ministers/Administrators of all the States/UTs and letter No. 16-1/2014 DD-I dated 19.6.2014 from Shri Awanish Kumar Awasthi, Joint Secretary, Department of Disability Affairs addressed to all Secretaries/ Principal Secretaries of the States/UTs may be referred to in this regard.

4. I would like to once again request that suitable directions may be given to all concerned for taking appropriate measures in concrete and time-bound manner for incorporation of barrier free access to all public buildings and transportation. Similar provisions may be considered to be made in local municipal/building bye- laws in your State.
