

Sir,


I am directed to state that as you may be kindly aware the ECI's directions are that during the period of General/Bye elections, no election related officer should be transferred between the period of announcement of election/bye election till the completion of election process. Similarly during revision of electoral rolls, no officer connected with the revision of electoral roll works should be transferred between the period of draft publication and final publication. If the transfer cannot be avoided due to administrative exigencies, then prior approval of ECI should be obtained.

However, the Commission has recently been approached by some State Governments for according ex-post facto approval after the transfers already effected. This should be avoided in future.

Hence, you are requested to issue suitable directions to the concerned departments of your state.

Kindly acknowledge the receipt and ensure necessary action.
