Subject: Implementation of Supreme Court orders passed in Civil Appeal No. 4064 of 2004 titled S.D.Bandi V/s Divisional Traffic Officer, KSRTC & Ors dated 5.7.13 -vacation of Government accommodation thereof.

Sir/Madam,

It has generally been noticed that the Head of Departments do not intimate the date of retirement of their employees who have been allotted Government accommodation thereby causing inordinate delay in vacation of Government accommodation. In this regard Hon'ble Supreme Court in Civil Appeal-No.4064 of-2004 titled S.D. Bandi V/s Divisional Traffic Officer, KSRTC & Ors. has suggested that the Government accommodation be got vacated in time as admissible under rules. In order to implement the suggestion of Supreme Court, it is necessary that all Head of Departments endorse a copy of orders of retirement, issued annually with reference to their employees posted in Shimla to this Directorate.

You are, therefore, requested that a list of retiring Officers/Officials may kindly be supplied to this Directorate annually, so that Government accommodation be got vacated in time from unauthorised occupants. It is further requested that copy of all transfer orders issued with reference to employees posted out of Shimla town may also be endorsed to this office so that process to get the Government accommodation vacated be initiated by the Directorate well in time.
