

I am directed to invite your attention to the subject cited above and to say that the Hon'ble High Court of Himachal Pradesh in CWPIL No. 201 of 2017 titled Court on its own motion Versus State of H.P. & another has passed the following order on 19-12-2017, after taking on record the reply affidavit so filed by the State, as under:

- 6. The State is bound by the affidavit and as such, petition is disposed of with a direction that henceforth no employee shall be given extension or be re-employed beyond the age of superannuation / retirement save and except, in accordance with the Chapter-22 of the Hand Book on Personnel Matters Vol-II (2nd Edition) and the provisions of Fundamental Rules 56(d). Letter and spirit of the criteria prescribed and the Rules framed be strictly followed.
- 2. It is, therefore, reiterated that the extension/re-employment beyond the age of retirement/superannuation has to be allowed in very rare and exceptional circumstances and strictly in accordance with provisions provided under Chapter-22 of the Hand Book on Personnel Matters Vol-II (2nd edition) and the provisions of FR 56 (d).

- 3. Extension in service/re-employment given if any, in government service without observance of the above prescribed provisions of rules can be construed as contempt of the Court and the concerned Administrative Department shall solely responsible for such violation.
