Your attention is invited to the Notification No.EDN-C-A(4)-1/2011-Vol-I, dated 30-07-2014 (**also uploaded on the departmental website**) vide which Government has extend the existing policy titled "Policy to engage a Teacher(s) through School Management Committees purely on period basis in Elementary/ Higher Education Department of Himachal Pradesh and **also Clause-4 of the existing policy vide which Provisions of selection Committee has been modified by the Government.**

Further, your attention is invited to the Notification No.EDN-C-A(4)-1/2011-Vol-I dated 16-08-2014(**also uploaded on the departmental website**) vide which existing policy notified by the Government vide Notification No.EDN-C-A(4)-1/2011, dated 17-07-2012 has been extended to all schools which were upgraded during academic session 2013-14 & 2014-15 irrespective of the area in which they fall and to all those sanctioned posts of teaching cadre which have remained vacant for over 2 years from the date of issue of notification dated 16-08-2014.

In this connection, it has come to the notice of undersigned that some schools are not abiding ^{by} the instructions issued vide above referred notifications i.e. "**Clause-4, Chairperson of the Selection Committee will be SDM of the concerned Sub-Division**" which is in gross violation of the orders /instructions issued by the government.

Therefore, you are hereby directed to issue necessary instructions to all field functionaries under your control to comply with the orders issued vide above referred notifications dated 30-07-2014 & dated 16-08-2014 (**copies once again enclosed**) in letter and spirit.


