This is with reference of letter received from Under Secretary (Home) to the Government of Himachal Pradesh received through The Additional Secretary (Education) to the Govt. of Himachal Pradesh letter No. EDN-B-Chh(10)-6/2010 dated 22-6-2015 on the subject cited above.

The UN General Assembly in a Resolution passed in December, 1987, proclaimed 26th June of each year as the "International Day against Drug Abuse and Illicit Trafficking. The Programme could include the following:-


- Public meeting in areas and among target groups vulnerable to drug abuse and HIV(Street Children, Jail inmates, Truck drivers, Slums etc)
- Seminars on drug abuse in training institutions/voluntary organizations
- Workshops to evolve new coordinated strategies for supply reduction and demand reduction by various enforcement agencies/NGOs
- Exhibition on drug abuse in different cities and towns
- Flashing of SMS through various service providers
- Regional languages programmes to be telecast broadcast by Doordarshan All India Radio and other electronics channels
- Wide publicity by way of displaying and distribution of banners, posters, pamphlets, slide show in cinemas etc.

In this connection, you are directed to give necessary instructions to the Principals/Headmasters under your jurisdiction to celebrate International day against Drug Abuse and illicit trafficking continuously for a fortnight to create awareness among students & public against the menace of drugs.

Further, all the Principals of Govt. Colleges/Govt. Aided colleges are also directed to organize similar programme in their respective colleges.
