No.HFW-H/IYCF/2013-21865 dated 01-06-2017, received from the Mission Director (NHM), Himachal Pradesh wherein, it has been intimated that to effectively address the issue, like last year, this year also the Government of Himachal Pradesh is observing "Intensified Diarrhoea Control fortnight (IDCF)" w.e.f. 12th to 24th June 2017 with the ultimate aim of Zero child deaths due to childhood diarrhea.

The key activities to be undertaken at Schools level are as under:-

- To make the children aware about the benefits of cleanliness, hygiene and hand washing before meals. Safe drinking water to be ensured in Schools and hand washing to be observed before Mid-Day Meal in all the Government Senior Secondary and High Schools.
- Handmade posters and drawings on Hand washing to be displayed and all
 children should be educated to wash hands in a proper manner.
- During Morning Assembly, message on importance of Wash (washing hands, sanitation and hygiene) to be delivered to all students.
- Organize essay writing / speech/ painting competition on importance of WASH alongwith the Health Department.

- Emphasis on use of Toilets, Stop open defecation, use of ORS and Zinc, lecture by BMO/MO on WASH may be arranged in Schools with coordination of Health Department.
- Rally by School Students as ambassadors of promoting use of ORS and Zinc, hand washing in community can also be organized.

In view of aforementioned, you are directed to take appropriate action in the matter accordingly and extend full support to the authorities of Health Department as and when desired by them.
