Subject: Unique I.D. for the NGOs/VOs through NGO-DARPAN Portal of NITI Aayog for processing of their applications for consideration of grants under the Scheme of Assistance to Voluntary Organization working for the Welfare of OBCs implemented through NGOs/VOs by the Ministry -regarding.

Sir/Madam,

I am directed to refer to the above mentioned subject and to say that online processing of Grants-in-Ald (GIA) proposals relating to the Central Sector Scheme of Assistance to Voluntary Organization Working for the welfare of other Backward Classes (OBCs). As per the procedure implemented from 2014-15, the online applications made by Non-Governmental Organizations (NGOs) are required to be forwarded to this Ministry by the respective State Governments, along with the recommendations of the State Level Committee, so as to enable the Ministry to process the cases and release the GIA as early as possible.

- In this contest, it may be submitted that the NITI Aayog has developed the NGO Partnership System (NGO-PS Portal) to facilitate the sign up of Valuntary Organization (VOs) and NGOs receiving financial assistance in the form of GIA under various welfare Schemes administered by Central Ministries/Departments. On successful sign up in the portal, a Unique ID is generated for the VOs/NGOs. This Unique ID is used as a mandatory requirement when the VOs/NGOs approach the Government for grants. The NITI Aayog has also informed that it has been decided to make Permanent Account Number (PAN) of the VOs/NGOs as mandatory information for registration with the NGO-PS Portal, Further, it has also been decided to make it mandatory to furnish the PAN and Aadhar Numbers of the Office Bearers of the VOs/NGOs before these organizations become eligible to apply for grants.
- You are therefore requested to issue necessary instructions to all the VOs/NGOs applying for GIA under the NGO Scheme for OBCs, to comply with the requirement of mandatory registration with NGO-PS Portal of NITI Aayog and to quote the Unique ID Number generated on such registration and to furnish the Aadhaar Number, PAN, E-mail ID and Mobile Number of each of its Office Bearer/Board of Directors/Managing Committee Members/Board of Trustees, as the case may be.
