Subject:- Regarding Free Travel Facility to the Students of Government
School in HRTC Buses.

Memo,

This is with reference to letter No.Tpt.-F(4)1/2008-II, dated Nil &
No.HO:5(CP)/Free Travelling to students/2012-13, dated 15-03-2013, received from the
Additional Chief Secretary (Transport) to the Govt. of Himachal Pradesh & Managing
Director, Himachal Road Transport Corporation, Shimla-3, on the subject cited above.

In this connection, it is informed that State Government has decided
to provide free travel facility to the students of Government Schools to undertake their
studies with the following terms & conditions:-

1. **This facility will be provided w.e.f. 01-04-2013 to all the students of Government schools all over Himachal Pradesh from their residence to school and back only except on gazetted / school holidays.**
2. **This facility will be provided only in ordinary HRTC buses / JNNURM buses operated by HRTC and no special bus will be deployed by the HRTC for this purpose.**
3. **This facility will be provided on the production of photo identity card by the student duly issued by the Headmaster / Principal of the concerned school clearly indicating the place of residence / school of the student. The facility will be provided only if the student is in school uniform in which the photo Identity Card has been issued in his / her favour by the concerned school.**


Further, a specimen copy of devised Identity Card (copy enclosed),
received from the Himachal Road Transport Corporation, **which will be prepared by the**

concerned school within a week time and get countersigned from the nearest Regional Manager of H.R.T.C.

Therefore, you are hereby directed to issue necessary instructions to all the Principals / Headmasters of Govt. Sr. Sec. / High Schools under your control to take appropriate action in the matter accordingly in time bound manner, so that instructions of the State Government could be implemented w.e.f. 01-04-2013.
