Subject: - Implementation of New online HPOLTIS.

Sir,

The system of preparation of bills by the DDOs and their presentation of bills in treasuries was under consideration of the Government for past some time. The bills are processed manually in treasuries and the entire bill is digitized in treasuries. The digitalized bills enable treasuries to prepare of account for Accountant General. This system not only has time consuming and avoidable data entry but is also prone to errors. It has hampers leveraging of other web based applications.

Therefore, in order to remove all the short coming of the present system, new online system has been developed and made operational. The Government of Himachal Pradesh has launched the online HPOLTIS and decided to rollout the same w.e.f 1<sup>st</sup> April, 2016 for all DDOs in all treasuries in the State. This will enable:-

1. Preparation and generation of all bills online by the DDOs and submission of these to concerned treasury from 1<sup>st</sup> April, 2016 onward. No manual bills will not be entertained after 1.4.2016.
2. DDOs will have to take printout of online bills. Signed bills shall be submitted to treasuries for processing. The bill printout shall continue till AGHP agree to do away with physical bills.
3. The GPF sanction and corresponding bills shall also be generated through online system. Physical GPF sanction shall not be sent to the office of AGHP and attached treasuries by GPF sanctioning authority.

You are, therefore, requested to direct all DDOs under your control to prepare and submit the bills online to concerned treasuries alongwith printouts for processing from 1.4.2016 onward.
