Subject: Regarding providing special buses for tours.

Sir,

It is informed you that recently, the Himachal Road Transport Corporation has introduced 800 Nos latest technology buses in the Pradesh. These buses are equipped with latest technology and safe for the passengers. It has been observed that some of Departments are preferring to hire private buses for conducting the tour within and outside the State mainly on the reason that private operators offer less charges than the Corporation. After the introduction 800 Nos new buses, the Corporation has also decided offer their buses to the Government Departments on very nominal rates even less than the rates offered by the private operators. You will appreciate that our crew is well trained and drive the bus more safely that the drivers of the Private Operators. It has also been observed that HRTC is providing the buses to the students for colleges but in case of conducting the student tours, the private buses are being hired by the schools/colleges authority. By hiring the private buses, the Government revenue goes to private hands whereas in case, you hire our buses, the revenue goes to Government exchequer, which is used for welfare of the State. This act will also minimize the probability of pilferage of revenue.
