Subject: - Issue of certificate in favour of re-employed Ex-servicemen with Education departments.

Sir,

I am directed to refer to your letter No. EDN-HE(19)-B(5)-1/2010 dated 27.9.2014 on the subject cited above and to say that the matter has been examined in consultation with the Finance Department. The Finance Department has observed that the "State Government has issued its own instructions for grant of dearness relief on pension to re-employed pensioners/family pensioners vide O.M. No. Fin-C-D(1)-1/2000 dated 22.1.2001. As per para-2 of the O.M. dated 22.1.2001 ibid, the dearness relief on pension will not be admissible to those ex-servicemen in whose case the pay is fixed above the minimum of the pay scale of the civil post to which they are re-employed. Accordingly, those ex-servicemen whose pay on re-employment in the civil service has been fixed above the minimum of the pay scale of the civil post due to grant of advance increments will not be eligible to get dearness relief on pension during such re-employment in civil service. In so far as the provisions of Circular No. 165 dated 22.2.2013 are concerned, same will not apply to the persons re-employed in State Government service."

You are, therefore, requested to consider and decide the cases of ex-servicemen in view of the above advice accordingly at your end.


