## Terms and conditions of regularization to the post of Peon /LA

- The candidate concerned will have to take an oath of allegiance and faithfulness to the constitution of India.
- The concerned candidate will have to take an oath to allegiance and faithfulness to the constitution of India
- The candidate's regularization/retention in service is subject to his/her character and antecedents being found satisfactory through the Deputy Director of Hr./ Edu. Head of the institution concerned with in stipulated period of three months.
- The concerned candidate shall have to produce a character certificate from a Gazetted officer to whom he/she is known for the last ten years.
