No. 37 of 2016

[29th July, 2016.]

An Act to amend the Lokpal and Lokayuktas Act, 2013

Built enacted by Parliament in the Sixty-seventh Year of the Republic of India as follows:-

1. (1) This Act may be called the Lokpal and Lokayuktas (Amendment) Act, 2016.

(2) It shall be deemed to have come into force on the 16th day of January, 2014.

2. On and from the date of commencement of the Lokpal and Lokayuktus Act, 2013 (hereinafter referred to as the principal Act), for section 44, the following section shall be substituted, and shall be deemed to have been substituted, namely:-

"44. On and from the date of commencement of this Act, every public servant. Declaration of shall make a declaration of his assets and liabilities in such form and manner as may be
